3. To petition the executive board for reimbursement of expenditures



2. To research and present to the executive board at its first meeting availability and fees for three hotels in the selected host city.


Amend to Read:

2. To appoint committees, unless otherwise specified by this constitution or the resolution creating the committee.


Amend to Read:


Amend to Read:

I suggest the following amendment to Article VII Committees, Section 3, Subsection D, Number 4 and Number 5 of the Texas Junior College Student Government Association Constitution.

Current Text:

4. The committee shall be responsible for judging each competition. The guidelines will then be presented in the last meeting of the General Assembly for approval. Once approved the guidelines will be published in the registration packet prior to the following state convention. The committee shall use a scorecard system to ensure that each college competing fulfills the criteria requirements of each competition. The committee may also recommend changes in the number of competitions to the General Assembly.
5. The advisor of the school serving as chair shall serve as an ex officio member of this committee.
